In exercise of the powers conferred by Section 45 K (1) of the Multi-State Cooperative Societies (MSCS) Act 2002, as amended by the MSCS amendment Act 2023 read with Rule 19F (a) of the MSCS Rules 2002(as amended in 2023), the Cooperative Election Authority hereby appoints District Magistrate, Gorakhpur, Uttar Pradesh as Returning Officer for conducting Elections as under:

2. Delegate election shall be held as per para 26 (d) of Bye-Laws which inter-alia provides that there shall be, "One delegate for every one hundred member but not exceeding 20 from each constituency.

3. Delegate election to be conducted by CEO/Secretary (under the supervision of Returning Officer) of the society and list of elected delegates submitted to Returning Officer before 10<sup>th</sup> February, 2025.

4. In view of Rule 19(H)(2) of the MSCS Rule 2002 (as amended in 2023), the Election Program for conducting election of the aforementioned Society is enclosed. RO is requested to ensure the election is conducted as per the MSCS Act, 2002 and Rules framed there under.

5. After conduct of Elections of Board of Directors, the RO is mandated to submit the requisite details in Format 19 M (for members of the Board of Directors) under Rule 19 M for seeking prior approval of the Cooperative Election Authority.

6. After conduct of Elections of Office Bearer (One Chairman & One Vice-Chairman), the RO shall submit the requisite details in Format 19 N for seeking **prior approval** of CEA before declaration of results.



7. Returning Officer shall ensure that the Society prominently displays the **List of Eligible Voters, Election Program and Final List of the Contesting Candidates**, and other related important documents on the website of the society for enabling free, fair and transparent elections.


8. Wide publicity to be given in the local News Paper & send SMS to members for participation/ holding of Elections in terms of provision of the MSCS Act and the rules framed there under.

9. Instructions for filling-up of the Format-M and N have been appended below the Format 'M' and 'N', the same should be scrupulously followed by the Returning Officer.

10. It is also requested to provide the details about basic pay of RO and ARO and other polling officers in the enclosed Performa to claim remuneration from the society in connection with discharge of duties for conduct of election as RO/ARO/Polling personnel etc.
